## Examples

- **Example Siting/Planning /Permit Issues**
  - Provide evidence cases from other countries
- **Example Wind Measurement Issues**
  - Advise specifications of measurement for bankable requirements;
  - Review suspicious wind data and advice for troubleshooting
- **Example Project Documentation Issues**
  - Respond to any specific question in relation to preparation of a bankable FS Report or a Tender Specification for Wind Turbines

## Language

- The preferred language is English, because our German wind power experts have to understand the issue;
- Inquiries sent in Vietnamese may need longer response time

## Information & Confidentiality

- Depending on the nature of the inquiry GIZ will require certain minimum standards of documentation of the issue in form of project relevant documents and data (e.g. installation report or data samples of wind measurement)
